### SUPERINTENDENT'S REPORT

To the School Board and Citizens of Easton:

The total enrollment in your school last year was 23, with an average membership of 21.28 and a percentage of attendance of 94.3%. There were 19 cases of tardiness. The percentage of attendance was somewhat better than that of the previous year. Two pupils attended Dow Academy.

The total enrollment this year is 22 with a membership of 19 at the present time. There are two pupils attending Dow Academy.

Miss Catherine McGloin of Braintree, Mass., replaced Miss Crawford who resigned. Miss McGloin is a graduate of Bridgewater State Teachers College.

The new revised Elson-Gray reading system has been continued through grades three and four. New literature and language books have been purchased for grades seven and eight this year.

It has been necessary to increase several items of the budget for next year because of increased costs and it will be necessary to raise and appropriate \$1,400.
